Dear Secretary Sebelius:

We are writing to express our opposition to guidelines issued by the Department of Health and Human Services on August 3, which constitute an unprecedented effort by the federal government to dictate the terms of private health insurance coverage.

Specifically, the imposition of mandated coverage for sterilization and contraceptives, of particular note abortifacient contraceptives and devices, stands to significantly expand health care costs and subjects many persons of good will to government-forced ethical dilemmas. Freedom of conscience is a fundamental American principle, and insurers, plan sponsors, and individuals should remain free from government coercion when deciding whether or not to offer or purchase particular types of health insurance coverage.

Additionally, this mandate will force many employers - particularly religious institutions - to choose between their convictions and livelihood, to either violate their deeply held beliefs, drop health care coverage, or cease providing health care services to the general public, disproportionately affecting vulnerable populations. We therefore respectfully request that the Department take these concerns into account and revise the August 3 interim final rule accordingly to protect the conscience rights of Americans.
