## **ORGANIZATION & PURPOSE**

Since 1999 the Protection of Conscience Project has been working to ensure that health care providers can provide the best care possible for their patients without violating their own personal and professional integrity. The Project is a non-denominational, nonprofit initiative supported by a project team and advisory board who serve without remuneration. It operates a website to advocate for protection of conscience laws, to promote understanding and assist in reasoned public discussion, and to facilitate communication among conscience advocates.

### **GENERAL POLICY**

The Project does not take a position on the morality of contentious procedures. Instead, it critiques policies of coercion and encourages accommodation of freedom of conscience. The Project does not direct or manage protection of conscience initiatives.

## **SCOPE & LIMITATIONS**

Project activities are limited to the protection of conscience in the delivery of health care. This does not imply that freedom of conscience in other contexts is less important.

Laws may limit freedom of conscience by preventing people from doing everything that they want to do. But forcing people to do what they believe to be wrong is contrary to the best traditions and aspirations of liberal democracy.

The Project advocates for freedom of conscience in this most essential and foundational sense. Health care providers must not be forced to do what they believe to be wrong, or punished for refusing to do so.

He is widely recognized as an expert in medical ethics, with a particular focus on Jewish medical ethics. Dr. Glick has been honoured with a Lifetime Achievement Award as part of the Nefesh B'Nefesh Bonei Zion Awards, recognizing his significant contributions to the State of Israel.

#### Mary Neal, Ph.D, LLB Honours, LLM Senior Lecturer in Law, University of Strathclyde, Glasgow, United Kingdom

Dr. Mary Neal researches, writes, and teaches in the fields of Healthcare Law and Bioethics, focusing on beginning and end-of-life issues. In 2014-15, she was Adviser to the Scottish Parliamentary Committee scrutinising the Assisted Suicide (Scotland) Bill, and she is a current member [2018] of the British Medical Association's Medical Ethics Committee. Prof. Oderberg is Editor of Ratio, an international journal of analytic philosophy, and Senior Fellow of the Higher Education Academy. He is the author of many articles in metaphysics, ethics, philosophy of religion and philosophy of science. His books explore moral theory, applied ethics, bioethics and natural law. His forthcoming book, The Metaphysics of Good and Evil, is based on the Hourani Lectures in Ethics he delivered at SUNY Buffalo. Prof. Oderberg has been working on freedom of conscience in health care for several years, with a recent focus on the ethics of cooperation. He is the author of the Declaration of Support of Conscientious Objection in Health Care (https://proconpro.org/conscience-dso).

Dr. Sachedina is an American/Canadian citizen born in Tanzania. He has been conducting research and writing in the field of Islamic Law, Ethics, and Theology (Sunni and Shiite) for more than two decades.
